Background

ASEAN-Japan Centre (AJC) is an intergovernmental organization promoting exports from the ASEAN Member States to Japan while revitalizing investment, tourism as well as people-topeople exchanges between the ASEAN Member States and Japan. AJC commits to realize the ASEAN-Japan Friendship and Cooperation vision, contribute to recovery from the COVID-19 pandemic, and promote inclusive, sustainable, and human-centred trade, investment, tourism and people-to-people exchanges between ASEAN member states and Japan. Under this goal, AJC fosters leadership exchanges and empowering young people, women, and start-ups in ASEAN member states and Japan for mutual prosperity. Recovery from the COVID-19 pandemic is also one of the most important visions of ASEAN which is outlined in the ASEAN Comprehensive Recovery Framework (ACRF).





Presentation & Feedback session


• 7-10 minutes presentation time will be given to each presenter.



• Maximum **5 minutes** feedbacks by the panel members to promote presenters' business further and foster other audiences' entrepreneurship.




• The panel members and participants assess each presentation through voting. The top 5 presenters will be awarded.
