ASEAN-Japan Centre is going to co-host a webinar "Nghe An Province in Viet Nam as a New Strategic Manufacturing Hub" with WHA Industrial Development.

Nghe An province in Viet Nam has been one of the attractive investment destinations for both domestic and international businesses. Its strong exports, positive regional domestic products, increasing industrial zones and adequate source of labour are some drivers of its provincial investment attraction. Nghe An has set a target of achieving a total export revenue of US\$1.2 billion for 2021, an increase of 7.1 percent compared to 2020.

This webinar covers a range of topics surrounding the investment potential in Nghe An Province, Viet Nam from the Vietnam-Japan cooperation, brief economic overview, Investment Policy overview and incentives, advantages to government support to FDIs.
